

## **Proposed By-Law Change**

BY-LAWS OF THE CTAGA CTAGA REPORT NO. 4

## ARTICLE II MEETING OF MEMBERS

SECTION 2. QUORUM: Forty-five (45) members or Thirty-three (33) percent of the full membership (whichever is less) shall constitute a quorum for the transaction of club business, but a smaller number may adjourn to a subsequent date. Each full member shall be entitled to vote in person. The secretary shall conduct a count at each meeting and announce whether a quorum is present before votes are taken. A majority vote of the members present and voting shall be required to pass a motion of ordinary business. All motions passed by vote of the membership shall be published in the next issue of the club newsletter.

- a. There will be no quorum requirement for voting probationary members into full membership. All probationary requirements must be fulfilled as defined in Article III, Section 1.
- b. There will be no quorum requirement for an applicant seeking reinstatement.

## ARTICLE III MEMBERSHIP AND DUES

SECTION 1. QUALIFICATION AND INDUCTION OF MEMBERS

Completion of each of the prescribed tasks shall be verified by a club officer or event captain. After satisfactory completion of all probationary conditions, full membership will be voted on by the members at a regular meeting. There is no quorum requirement for this vote. Upon receiving a 70% affirmative vote and payment of annual dues prorated to the nearest month, the candidate will become a full member.

An applicant who was previously a member of the CTAGA in good standing and who voluntarily terminated membership may apply for reinstatement and have full membership voted upon without having to serve the 12-month probation. The applicant can request reinstatement at a club meeting. The applicant's name will then be published in the Ramrod and a vote will be held at the next month's club meeting. There will be no quorum requirement for a reinstatement vote. Upon receiving a 70% affirmative vote of the members at a regular meeting and upon payment of pro-rated dues, full membership shall be reinstated.


