CTAGA Board Minutes - December 8, 2022

Members Present: Jim Fry, Ken Sackett, Bob Bartlett, Ken Henderson, Doug Bryant, Tim Pinkerton, Cindy Pinkerton

Members Absent: Joe Base

Jim Fry, President, opened the meeting. Discussion of the nominations for the Jack Steventon award and a vote was completed. Lori Heath, Green Card, is eligible for full membership vote in December.

Ken Sackett- No issues to report.

Bob Bartlett- Discussed possible change of the billboard design for the Gun Show, due to others using the same design. Will wait until the big boards are in need of replacement.

Doug Bryant- There is no Match Director yet for the Tom Horn match in January. If no one volunteers by the General Meeting, the match will be canceled.

Cindy Pinkerton- The 2023 Calendar will be sent out ASAP.

Ken Henderson- The Venue for the 2023 Banquet is set and the remainder of the deposit is due. The food was discussed and decided upon a buffet style meal. The venue requires a specific bartending service, Ken will contact and see what they charge, before a decision will be made on having the service. The Banquet will be over the budget submitted; the board voted to increase the budget for the banquet. Club members may bring one guest for free and additional guests for \$25 each. Members are responsible for any guests and reservations made and not canceled by registration cut off date, they will be assessed \$25 per person on their 2023/24 dues.

Extra guest and people who no-show to the banquet will be charged \$25. Registration form will be sent to the members ASAP.

Tim Pinkerton- November monthly report given. The new Money Market accounts made approximately 4X as much as previously. Discussion about the new AR-500 steel targets- price quotes were obtained for the steel and cutting, match directors were contacted about needs and wants for the various disciplines. There is some overlap. Current target size is 16X16 inches and new target 18X24 inches. The need for and the different Shotgun targets were also discussed. The next step is to look into other needs for targets around the range and the different options for stands.

Short discussion was had about need for by-law changes to the rules for a quorum at the meetings and how to conduct business, as we are routinely not having a quorum at the meetings. We will review the current wording on the issue and discuss possible changes.

Tim Pinkerton- We are earning about 4 times the interest now for moving some money to a 17-month CD from the Money Market account.

Old Business: Tim Pinkerton discussed the need to purchase new steel targets made from 3/8" AR 500 steel. He has discussed needs with the match directors. We are getting quotes for different options. Discussion was had on the size and shape needed, need for shotgun targets, what ammo can be used, replacing the 100 and 200 yard range targets, Muzzle loading target needs, different target stand styles and safety concerns. The comments included that the original steel targets are approximately 40 years old as they were installed when Teddy Webb was Range Officer.

New Business: By Law changes are needed in regards to the lack of having a Quorum regularly. Tim Pinkerton presented the discussion that was had at the Board meeting., including the new language proposed. The proposed changes are presented elsewhere in the Ramrod.

Program: Wes Lumry presented a talk on Black Powder guns with 45/70 reloads and bullets. He showed his original Springfield Trapdoor gun.

Proposed by-law changes.

Current by-law (12/2022)

Article II Meeting of Members

Section 1. MONTHLY MEETING: Monthly meetings shall be held on a date and time decided by the membership. No notice of such meetings shall be required except when a vote for officers, by-law change, removal of a Director, or a vote on termination or disciplinary action of a member is taken.

Section 2. Quorum: Forty-five (45) members or Thirty-three (33) percent of the full membership (whichever is less) shall constitute a quorum for the transaction of business, but a small number may adjourn to a subsequent date. Each full member shall be entitled to vote in person. The secretary shall conduct a count at each meeting and announce whether a quorum is present before votes are taken. A majority vote of the members present and voting shall be required to pass a motion of ordinary business. All motions passed by vote of the membership shall be published in the next issue of the club newsletter.

Exceptions:

- a. There will be no quorum requirement for voting probationary members into full membership. All probationary requirements must be fulfilled as defined in Article III, Section 1.
- b. There will be no quorum requirement for an applicant seeking reinstatement.

Proposed changes in bold below (new exceptions)

c. **Ordinary business: In the event a quorum is not present for ordinary business, a motion may be made and seconded with discussion, no vote will be taken at that meeting. Rather the motion and summary of discussion will be published in the monthly newsletter. At the next monthly meeting, the motion will be brought up under old business and, after further discussion, will be voted on and decided by majority vote of the members present, regardless if a quorum is present. This exception does not apply to by-law changes, which still require a full quorum as defined in this Article II, Section 2.**

d. **Election of officers: Officers nominated at the May meeting will be published in the May newsletter, to be voted on at the June meeting (as described in Article IV, Section 9). The previously nominated officers can be elected at the June meeting by a majority vote, regardless if there is a quorum present in the June meeting. In the event a position was not filled in the May meeting and a quorum is not present in June, the board will appoint someone to fill the position for the term.**

e. **Approval of budget: The budget is presented at the August meeting. In the event there is not a quorum at the August meeting, a summary of the budget will be published in the newsletter. The budget will be voted on and decided by the majority of members present at the next meeting, regardless if a quorum is**
